

WINONA COUNTY ORDINANCE NO. 31-7/13/99

An ordinance to prohibit parking of vehicles along designated sections of County State Aid Highway 25, including both shoulders, and to establish penalties for violations of the Ordinance.

THE COUNTY BOARD OF WINONA COUNTY ORDAINS:

No person shall stand, stop, park or leave standing any vehicle, as defined in Minn. Stat. 169.01, Subd. 2, at the locations described below at any time during the twenty-four hours of the day, seven days weekly, throughout the calendar year on both sides of County State Aid Highway 25 from the junction with County State Aid Highway 12 to a point located Five Hundred Ten (510) feet to the west.

As a means of notifying the public of the provisions of this Ordinance creating no-parking zones, the Winona County Highway Engineer is authorized and directed to paint and erect signs per the standards on painting and erection of signs which are contained in the Uniform Manual of Traffic Control Devices.

It is a petty misdemeanor punishable by a fine of not more than \$200.00 for any person to violate any provision of this Ordinance.

Any police officer, as defined in Minn. Stat. 169.01, Subd. 27, is authorized to move, pursuant to Minn. Stat. 169.041, a vehicle to any public garage or other place of safety at the expense of the driver or owner or other person in charge of the vehicle when the vehicle has been parked or left standing in violation of the Ordinance. Any vehicle so towed shall be released to the driver or owner or other person in charge of the vehicle only upon the payment of the towing and storage charges.

This ordinance is effective upon publication and the placing of no-parking signs designating the no-parking zones by the Winona County Highway Engineer.


